Report Highlights:

On November 26, 2015, AQSIQ released the revised "Implementation Catalogue for Registration of Overseas Manufacturers of Imported Food" (AQSIQ Public Notice [2015] No. 138), which is the implementing catalogue of products for the <u>AQSIQ Decree 145 for Registration of Overseas</u> <u>Manufacturers of Imported Food</u>. The revised Catalogue removes colostrum from the dairy category and adds lactose. In addition, the Catalogue now includes cabilose (edible bird nest). This report provides unofficial translation of the AQSIQ Public Notice [2015] No.138.

On November 26, 2015, AQSIQ released the revised "Implementation Catalogue for Registration of Overseas Manufacturers of Imported Food" (AQSIQ Public Notice [2015] No. 138), which is the implementing catalogue of products for the <u>AQSIQ Decree 145 for Registration of Overseas</u> <u>Manufacturers of Imported Food</u>. In comparison to the last Implementing Catalogue (AQSIQ Public Notice [2012] No.73), the current Catalogue presents the following changes:

- Dairy: removed colostrum;
- Dairy: added lactose;
- Added the category of cabilose, or edible bird nest.

The catalogue comes into effect immediately, while registration of cabilose manufacturers will be implemented on January 1, 2016. This report provides unofficial translation of the AQSIQ Public Notice [2015] No.138.

BEGIN TRANSLATION

AQSIQ Notice Concerning Updating the "Implementation Catalogue for Registration of Overseas Manufacturers of Imported Food" [2015] No. 138

Pursuant to the *Food Safety Law* and its implementation rules, *Law of the People's Republic of China on Import and Export Commodity Inspection* and its implementation rules, and the *Administrative Measures for Registration of Overseas Manufacturers of Imported Food* (AQSIQ Decree 145), we are issuing this public notice for updating the "*Implementation Catalogue for Registration of Overseas Manufacturers of Imported Food*". Foreign food producers covered in the *Catalogue* could export their products to China only when the establishments are registered (with CNCA). Registration of the foreign producers of the imported cubilose (bird's nest) will be implemented on January 1, 2016.
