China Responds to U.S. 301 Announcement with Revised Product List

Report Highlights:

On June 16, 2018, the People's Republic of China's Ministry of Finance (MOF), State Council Tariff Commission (SCTC) announced a revised list of U.S. products subject to an additional 25-percent tariff in response to the U.S. 301 Investigation. The announcement is broken down into two schedules. Schedule I includes 545 total products, valued at approximately \$34.0 billion, which will enter into force on July 6, 2018, the same day the U.S. tariffs related to the 301 Investigation are enacted. 517 products on the list are food and agriculture-related products. Some of these same products are also subject to tariffs in China's response to the 232 Investigation. Post understands that these two additional sets of tariffs will be calculated in aggregate. U.S. exporters of these commodities should be aware that the new tariffs are effective July 6, and should check with local importers to verify changes in tariff treatment.

Executive Summary:

On June 16, 2018, MOF published a list of U.S. exports that will be subject to a 25-percent tariff increase. MOF stated that these tariffs were in accordance with the "People's Republic of China Foreign Trade Law," "The People's Republic of China Import and Export Tariff Regulations," other PRC laws and regulations, as well as the basic principles of international law. The June 16 announcement expanded the number of the U.S. products subject to additional tariffs, and effectively raises the applied tariff-level in comparison to MOF's April 2 announcement. See GAIN report [CH18017](#). The June 16 announcement noted that China Customs will assess additional duties on July 6, 2018.

The announcement also states that duties on certain U.S. products would be calculated in aggregate, meaning those products also affected by an additional tariff related to the U.S. 232 Investigation would be affected by both tariffs. The table below incorporates the Most-Favored-Nation (MFN) import tariff, as well as China's additional tariffs in response to the U.S. 232 and 301 Investigations in one place so that U.S. exporters can assess the total impact of China's trade actions against U.S. food and agriculture-related products.

The June 16 announcement is in response to the recent U.S. announcement of a list of products imported from China that will be subject to additional tariffs as part of the U.S. response to China's unfair trade practices related to the forced transfer of American technology and intellectual property.

General Information:

This report summarizes the announcement titled "Notice of \$50 Billion U.S. Dollars of Imported Goods Expropriated" published on the People's Republic of China's Ministry of Finance website on June 16, 2018.

This GAIN report contains an unofficial translation of the MOF, SCTC announcement, including an example of the tariff calculation methodology and an unofficial translated schedule of the products subject to these tariff increases, which will effective on July 6, 2018.

Disclaimer:

This summary is based on a cursory review of the subject announcement and therefore should not, under any circumstances, be viewed as a definitive reading of the regulation in question, or of its implications for U.S. agricultural export trade interests. In the event of a discrepancy or discrepancies between this summary and the complete regulation or announcement as published in Mandarin, the latter shall prevail.

Product Scope:

MOF's announcement divides the tariff treatment into two groups. Schedule I includes 545 products, of which, 517 products are agriculture and agriculture-related products. These products include oilseeds, cereals, livestock and animal products, horticultural products, as well as cotton, tobacco, and distilled spirits. In 2017, Chinese imports of these U.S. products totaled approximately \$19.6 billion. It should be noted that MOF expanded the product list from the proposed list announced on April 4, 2018 (See GAIN report [CH18018](#)), which included only 33 food and agriculture related product lines. Schedule II includes 114 products, none of which are agriculture and agriculture-related products. In both cases the additional tariff is 25 percent. Please refer to Appendix 2 for a schedule of specific product descriptions.

These tariffs will be applied in addition to existing tariffs (MFN tariff and 232 additional tariff, if appropriate) on an ad valorem basis for cost of goods, insurance, and freight (CIF) values.

Method of Tariff Calculation:

On April 4, MOF announced proposed tariffs in response to the U.S. 301 Investigation, which would raise the applied tariffs on U.S. exports to China. The same announcement also noted the following calculation methodology:

Tariff = Dutiable value x (current applied tariff rate + additionally imposed tariff rate)

On June 1, China announced MFN tariff cuts on approximately 388 food and agriculture products effective July 1.

The June 16 MOF announcement noted that the tariff calculation methodology as follows:

Tariff = Total collectable duty amount [Calculated according to current applied tariff rate] + dutiable value x additionally imposed tariff rate

Although the terminology is different, the calculation methodology is the same.

Products on Schedule I will be assessed aggregate tariff treatment on the dutiable value of goods, which remains constant accounting for both of China's additional tariff. The effective tariff rate will include the total percentage of the MFN tariff, 232 additional tariffs, and 301 additional tariffs. See Appendix 1 for examples and Appendix 2 for effective tax rates.

Timing:

In the June 16, 2018 announcement, MOF noted that the General Administration of China Customs (GACC) will begin applying additional tariffs on Schedule I products starting on July 6, 2018. Schedule II will enter into force at a later date (which is not stated and has not been determined). The tariffs in Schedule II remain subject to further ruling and a public comment period by MOF.

UNOFFICIAL TRANSLATION OF MINISTRY OF FINANCE ANNOUNCEMENT State Council Tariff Committee Announcement on “Imposing Tariffs on \$50 Billion Products Origin in the United States” Tariff Committee Notice [2018] No. 5

On June 15, 2018, the U.S. government released a list of goods subject to tariffs, which will impose a tariff of 25 percent on goods imported from China valued at about US \$50 billion. Of which, \$34 billion of goods will be subject to tariffs on July 6, 2018, and imposing tariffs on the \$16 billion of goods are soliciting public comments. The U.S. measure violated the relevant rules of the World Trade Organization and diverges from the consensus reached in the China-U.S. negotiations. The U.S. measure seriously infringes upon the legitimate rights and interests of the Chinese side, and threatens the interests of our country and people.

According to the "People's Republic of China Foreign Trade Law," "The People's Republic of China Import and Export Tariff Regulations," and other laws and regulations and the basic principles of international law, the State Council Tariff Committee decided to impose an additional 25 percent on 659 items of US\$50 billion imported goods originating in the United States. 545 items of approximately US\$34 billion in goods will be subject to additional tariffs on July 6, 2018, and the implementation date of additional tariffs on other goods will be announced separately. The relevant matters are as follows:

1. For 545 items such as agricultural products, automobiles, and aquatic products, tariffs shall be imposed on July 6, 2018. The specific commodity scopes are listed in Attached Schedule I.
2. For the 114 items such as chemical products, medical equipment and energy products, the implementation date of additional tariffs shall be announced separately. The specific commodity scopes are listed in Attached Schedule II.
3. For commodities listed in Schedule I and Schedule II originating in the United States, a 25 percent tariff will be imposed on the basis of the current taxation method and applicable tariff rates. The current in-bond tariffs and tariff-reduction (exemption) policies will remain unchanged. The tariff imposed this time will not be reduced or exempted.
4. After adding tariffs, the relevant import tax calculation formula:
Tariff = current applicable tariff + duty paid price × additional tariff rate

Consumer tax on import (price-based tax rate) = taxable price for consumer tax on
import × consumer tax proportional rate

Consumer tax on import (normquota tax rate) = import quantity × fixed consumer tax rate

Consumer tax on import (compound) = taxable price for consumer tax on import ×
consumer tax proportional rate + import quantity × fixed consumer tax rate

Taxable price for consumer tax on import (price-based tax rate) = (duty paid price +
tariffs) ÷ (1 – consumer tax proportional rate)

Taxable price for consumer tax on import (compound) = (duty paid price + tariffs +
import quantity × fixed consumer tax rate) ÷ (1 – consumer tax proportional rate)

VAT on import = taxable price for VAT on import × VAT rate on import

Taxable price for VAT on import = duty paid price + tariffs + consumer tax on import
