Pacific Northwest Event Sparks Interest Amongst Philippine Buyers

Report Highlights:

The FAS-organized “Grand Pacific Northwest Connection” achieved significant press coverage, allowed U.S. exporters to introduce new products to the market and garnered keen interest from multiple food and beverage (f&b) importers, distributors and trade customers. The menu showcase event highlighted a variety of high quality foods, wines and other beverages from the Pacific Northwest, and was co-hosted by FAS Manila and the U.S. Embassy on April 3, 2014, in partnership with the Alaska Seafood Marketing Institute, the U.S. Potato Board, and six U.S. and local companies. Held at the residence of the U.S. Embassy’s Deputy Chief of Mission, the event was attended by 100 guests including importers, hoteliers, restaurateurs, culinary professionals, and food, travel and lifestyle media representatives.

U.S. f&b exports to the Philippines grew by 15 percent in 2013 and reached a record \$1 billion. Due to the popularity of U.S. f&b products and their reputation for high quality, traders foresee continued strong growth in export sales to the Philippines, forecast to reach \$1.15 billion in 2014.
